- Allocation of funds for legal expenses: Like previous year, this year also Rs. 1. 5
  lakh be allocated to meet legal expenses. It was conveyed by ACFOA, 2021-22,
  that there are objection raised by Few Flat Owners by mail & verbally to pay the
  maintenance if AFCOA keeps paying for individual legal case expenses.
- Registration of Association (ACFOA) passed in previous year AGM but to be concluded— Discussions with vendors were informed to all the Owners. More details will be furnished in details to all the owners
- Guidelines for Durga Puja / Kali Puja Accounts/ Expenditure: Durga Puja should follow standard accounting guidelines.
   Kali puja as they do not have any bank account to operate can be exempted.
   ACFOA would recommend that any high amount bills can be processed through ACFOA accounts.
- Advertisements in club should be allowed during Durga Puja
- CCTV up gradation New committee to consider installation of CCTV for GYM, Club & lift entrance.
- Civil & Maintenance New committee to consider the following:

- 6 speed breakers to avoid speeding of vehicles in campus
- Convex safety traffic mirror near block 11 & 7
- Car space repair to avoid water logging
- Terrace repairing work for all blocks to clear water logging.

- 3 bookshelves for Library (considering reusing existing too)
- Story reading session for kids
- Theatre and cultural programs
- Yoga classes for resident (Paid)

#### • Fire & Safety

- Purchase of ladder till 4<sup>th</sup> floor
- Emergency exit other than ground floor
- Fire Alarm upgrade
- Water supply during fire emergency

#### 10. Miscellaneous Question Answer, Query Session:

Following question and queries were addressed during the session:

- Mr Jayanta Roy Chaudhury raised a query regarding the Security agencies fees
  which was explained that fees which are based on actual attendance and no of
  days.
- Mr Kaushik Dutta raised a query regarding difference in expenditure vs income leading to consumption of 1.5 lakh from the savings. Referring to the budget of discussion during EGM in March 2022 it was clarified that the last 2 years expenses are more than the income which is leading to consumption of unused maintenance funds. For more details refer to Annual reports shared for FY 2020-21 and 2021-22.
- Mr Sudip raised a query that receipt and payment is not a copy of Tally and ACFOA confirmed that all documents shared are from the final audit copy signed by the auditor, president, secretary and Treasurer.
- Mr Prosenjit & Mr Kuntal raised concerns regarding the Airport City vs Hazarduwari case details. The artifacts presented during the meeting are printed from the High court website and placed in ACFOA files. Further details will also be included with support of related people.
- ACFOA also considered conducting a meeting with CESC to understand what the benefits of recent changes are done by CESC.
